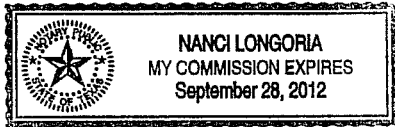
PERSONAL FINANCIAL STATEMENT AFFIDAVIT
