

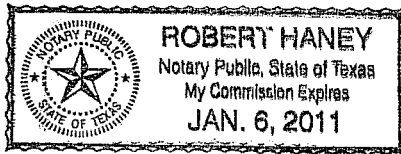
PERSONAL FINANCIAL STATEMENT AFFIDAVIT


