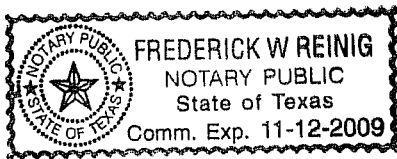

Explanation of Corrections:
